1.2 participation in animal handling is hazardous activity and may result in injury, loss, damage or death to me;

participation in animal handling requires certain skills. I declare that I have sufficient skills to be able to safely and properly participate in the 1.3 events;

animals can act in a sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises; 1.4 animal showing events will be held in close proximity to rides and large groups of people, and that there may be loud and unfamiliar noises

if the event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or 1.6 wind:

I agree to release the Suppliers and their employees from legal responsibility for the services I have been provided and/or activity I have participated in.
- I acknowledge and agree that my participation in the event and associated activities is a danger and may have inherent risks as a result of which 3 personal injury (and sometimes death) may occur. I acknowledge that the event and associated activities carry with them a significant risk of physical harm. WARNING UNDER THE FAIR TRADING ACT 1999
